5. Soft tissue injuries: a comprehensive and cutting edge analysis
6. All clinical syndromes and conditions

resulting from whiplash (WAD/CAD)

7. What forensic experts need to know about the various pain syndromes
8. Risk assessment: the fundamental key to modern forensic practice

The curriculum of Module Two incorporated training on all aspect of trauma management. Dr. Saladino was taught how to receive instruction on crash reconstruction and historical documentation in personal injury and forensic medicine applications, as well as the use of diagnostic imaging such as CT, MRI, PET, and EMG. Additionally, Dr. Saladino was taught the process of rendering an accurate case diagnosis in a personal injury review, and the successful case management of the soft tissue injuries sustained with emphasis placed on the review of the chiropractic portion of the case.

Module Three taught Dr. Saladino principles of impairment rating, forensic reporting, and successful medico-legal case management, including the importance of critical review documentation. He received instruction on objective documentation incases which require forensic examination and reporting, as well as the crucial role that objective and concise narrative reports play in the process of case management.

Module Four provided fascinating information on ways to use illustrative evidence and some of the Federal Rules of Evidence pertaining to the use of such evidence. He is also a frequent resource for national media such as CNN, MSNBC, Business Week, and others on the topic of insurance.


